**TEMPORARY FOR-HIRE LIMOUSINE
LICENSE APPLICATION
SUPER BOWL XLIV / PRO BOWL 2010**

1 INSTRUCTIONS:

Temporary licenses may be applied for by limousine operators currently licensed by a state or political subdivision of a state to engage in the limousine business or to operate a limousine as defined in Section 31-601 (u) of the Miami-Dade County Code, which states: "Limousine means a luxury limousine sedan, a stretch limousine, a super-stretch... which provides service on a pre-arranged basis only, which is dispatched by its central business location." Temporary licenses may also be applied for by limousine companies currently licensed by Miami-Dade County who desire to add vehicles to their fleets for the Super Bowl and/or Pro Bowl. Mail-in applications will be accepted from **November 16, 2009 through January 20, 2010**. After the application is reviewed for compliance, you will receive a decal for each limousine listed in the application via certified mail. Walk-in applications will be accepted at our office from **November 16, 2009 through February 5, 2010** and if all requirements are met, you will be able to receive your decal(s) the same day. Listed below are the classes of services and their definitions:

- LUXURY SEDAN:** A luxury, non-metered vehicle of a wheelbase size smaller than a stretch limousine, as defined by the Consumer Services Department. **ONLY THE MAKES AND MODELS ON THE CSD DEFINED LIST MAY BE USED** (attached). Vehicles must be black, white, silver or navy blue in color. No vehicle that exceeds five (5) model years of age will be licensed.
- STRETCH:** A sedan cut and stretched a minimum of forty-two (42) inches beyond its standard basis, manufactured to carry between six to eight persons, excluding the drivers. No vehicle that exceeds five (5) model years of age will be licensed.
- SUPER-STRETCH:** A luxury vehicle stretched a minimum of one hundred twenty (120) inches beyond its standard basis, manufactured to carry between nine or more passengers including the drivers. No vehicle that exceeds seven (7) model years of age will be licensed.

- Complete and notarize the application form. Type or print neatly.
- Submit as Attachment #1 a copy of the license issued to your company by a state or political subdivision of a state to engage in the limousine business or to operate a limousine.
- Submit as Attachment #2 copies of the Certificates of Insurance for each vehicle. Each certificate must include a Schedule of Insured Vehicles and Drivers. Each certificate of insurance must include limits of liability no less than one hundred thousand dollars (\$100,000.00) per person, and three hundred thousand dollars (\$300,000.00) per occurrence for bodily injury, and fifty thousand dollars (\$50,000.00) per occurrence for property damage.
- Submit as attachment #3 copies of valid driver's licenses for all chauffeurs listed on the application.
- Section 6 of the application must be completed by the holder of a current Miami-Dade County for-hire limousine license sponsoring the temporary license applicant.
- The fee for a temporary license is **\$100.00 per vehicle, per event**. A company that is not a holder of a current and valid Miami-Dade County for-hire limousine license must pay **\$100.00 per company, per event** in addition to the per vehicle fee. Your check or money order should be made payable to the Miami-Dade County "**Board of County Commissioners**". If applying in person, credit cards (VISA/MASTER CARD) will be accepted. Include \$5.00 extra if you wish to have the decals returned by certified mail
